Marine Conservation Plan; Bureau of Statistics and Plans; 2011. This plan describes how the Governor of Guam proposes to allocate funds obtained under a Pacific Insular Areas Fishery Agreements (PIAFA) or collected from fisheries violations with the Guam Exclusive Economic Zone (EEZ) for the period of 2011-2014. The document provides information on the process which the Marine Conservation Plan was developed and reviewed, the programmatic objectives determined to be funding priorities and the project activities to be undertaken.

### **ECONOMIC**

Mitigation Monitoring and Tracking Program Plan for Guam and CNMI Military Relocation Program; Naval Facilities Engineering Command (NAVFAC) Pacific; June 2011. This plan describes the framework for monitoring and tracking of mitigation measures what will be implemented by the Department of the Navy as part of the Guam and Commonwealth of the Northern Mariana Islands

(CNMI) Military Relocation Environmental Impact Statement/Record of Decision (EIS/ROD). The objectives of the mitigation monitoring and tracking program are to: 1) provide an effective management tool for the monitoring and tracking of the Department of the Navy mitigation measure projects associated with the Guam and CNMI Military Relocation Program; 2) provide a tracking system to document compliance with Department of the Navy mitigation requirements; and 3) provide a tracking system that will indicate status of Department of the Navy mitigation compliance across the program. Includes environmental planning schedule timelines for military relocation to Guam, roles and responsibilities of entities associated with the implementation of the 159 mitigation measures included in the Record of Decision, and recommendations.

Guam Guidebook; Guam Visitors Bureau; 2011. Easy to read guide that provides information on Guam's culture, historical landmarks, Guam's wildlife, shopping and entertainment, and safety tips. Includes map that identifies sightseeing areas, points of interests, and public beaches. Membership directory and E-Guidebook inserted in back pocket of booklet.

Government of Guam: Basic Financial Statements, Additional Information and Independent Auditors' Report, Year Ending September 30, 2010 (2010); Deloitte and Touche; Annually. This report presents the results of the audited financial statements of government activities, the aggregate discretely presented component units, each major fund, and the aggregate

remaining fund information of the Government of Guam as of and for the year ending September 30.
